EMPOWERING TEACHERS FOR DISABILITY-INCLUSIVE CLASSROOMS

- 1. The Division of Capiz will conduct a Three-Day training titled **Empowering Teacher for Disability-Inclusive Classrooms** on November 27-29, 2025. The venue will be announced later.
- 2. This activity aims to:
- a. explain and apply the key principles and components of an Individualized Education Plan (IEP);
 - b. design and present a Behavior Intervention Plan using evidence- based Behavior Management Techniques (BMTs) and Trauma-Informed Approaches suited to diverse learner needs:
 - c. demonstrate and adapt at least three Occupational and Speech Therapy strategies that can be implemented both at home and in the classroom to support learners with developmental and communication challenges;
 - d. develop and submit an Integrated Classroom Support Plan that aligns IEP goals with behavior management, occupational therapy, and speech therapy strategies—assessed using a DepEd-aligned rubric; and
 - c. reflect on current inclusive education practices and formulate an action plan to implement disability-inclusive strategies within their respective schools and learning contexts.
- 3. The list of program management team, monitoring team, resource persons, and participants, and training matrix are found in Enclosure No.1 and 2, respectively.
- 4. Expenses for the materials, food and accommodations of the participants, trainers and facilitators shall be charged against the downloaded SNED Fund. Travel expenses and per diems of school participants shall be charged against school MOOE. All expenses relative to the conduct of this activity are subject to usual accounting and auditing rules and regulations.
- 5. Participants and trainers are entitled to service credits in accordance with DepED Order No. 13, s. 2024 titled: *Revised Guidelines on the Grant of Vacation Service Credits for Teachers*. On the other hand, non-teaching personnel including the management staff shall be provided with Compensatory Time Off (CTO) as per Civil Service Commission (CSC) and Department of
