1. In reference to Advisory No. 033, s. 2025, titled **Administration of the Computer-Based National Career Assessment Examination for School Year 2025–2026**, this Office will conduct a **Meeting of Secondary and Integrated School Testing and ICT Coordinators** on **December 5, 2025, 9:00 a.m. at the WAB Building, Capiz National High School**, Fuentes Drive, Roxas City.
2. This activity aims to orient testing field personnel and facilitate the planning for the administration of the aforementioned assessment program.
3. Participants in this activity are **all Secondary and Integrated School Testing and ICT Coordinators**. They are required to bring data on the number of their Grade 10 learners, as well as school data on computer laboratory facilities, including capacity, internet stability, and reliability.
4. Expenses incurred in relation to the conduct of the above activity shall be charged against the National Assessment Systems for Basic Education (NASBE) Program Support Funds (PSF), while the transportation expenses of the participants shall be charged to their respective school MOOE/local funds, subject to the usual accounting and auditing rules and regulations.



ADMINISTRATION OF THE COMPUTER-BASED NATIONAL CAREER ASSESSMENT
EXAMINATION FOR SCHOOL YEAR 2025-2026

1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), with the assistance of the Regional Offices (ROs), Schools Division Offices (SDOs), and secondary school personnel, will administer the **Computer-Based National Career Assessment Examination (CB-NCAE)** to all **Grade 10 learners** currently enrolled in public and private schools with government permit or recognition. The examination will be conducted during the regular classes from **December 2025 to January 2026**, which will serve as the testing window.
2. The DTCs are encouraged to strictly check the school enrollment data submitted by their respective schools, before submitting to their RTCs as this Bureau **will not allow multiple submissions**.
3. Regional Testing Coordinators (RTCs) shall consolidate all submitted Grade 10 enrollment data from their respective DTCs on or before **November 14, 2025, Friday**, using the link https://bit.ly/2025NCAE_Masterlist. Should there be concerns on submission, please coordinate with **Ms. Trisha Loren F. Biñas**, Statistician II, at trisha.frogosa@deped.gov.ph.
4. A virtual orientation to discuss the test administration shall be conducted to RTCs, Regional Information Technology Officers (RITOs), DTCs, Division Information Technology Officers (DITOs), and Private Schools Supervisors through the following meeting details:
