1. This Office issues this SECOND CORRIGENDUM to correct and clarify certain detail in Memorandum No. 652, s. 2025 titled **PASIDUNGOG 2025 Awardees**, dated December 4, 2025, specifically addressing the issue on the wrong endorsement and evaluation of applicant for the Senior High School Teaching Related Awards.
2. Upon thorough verification, review and validation, the Division Awards Committee noted an error in the strand assignment of one applicant, resulting in the wrong evaluation cluster.
3. In line with this, the following correction is hereby issued:
 - a. **Strand Assignment of Applicant**
From: The applicant was mistakenly evaluated under General Academic Strand (GAS). It should have been endorsed and evaluated under the Humanities and Social Sciences Strand (HUMSS) Category
To: Upon transfer to correct strand, the applicant's documents underwent re-evaluation by the HUMMS Committee in accordance with the correct strand requirements
 - b. **Evaluation Status Update**
From: Ranked #4 under GAS and qualified within the Top 5
To: Ranked #8 under HUMSS based on proper strand criteria.

c. Award Eligibility

From: Eligible for the SHS Teaching-Related Award (within the Top 5 Rank)
To: Not eligible for an award under HUMSS due to ranking outside the Top 5; therefore, no award shall be given

d. Replacement of Rank in GAS

Due to the correction and transfer of the applicant to HUMSS, the next-in-rank applicant in GAS shall move up to occupy the vacated rank and be considered the eligible qualifier within the GAS Top 5 awardees. Accordingly, **Ms. JANET J. DIVINAGRACIA of Capiz National High School** is hereby elevated to the next rank within the GAS and is now confirmed as one of the Top 5 awardees under GAS.

4. This adjustment ensures fairness, accuracy, and integrity in the selection process across strands.
5. These corrections supersede all previously issued entries related to the above item. All concerned personnel/committees are directed to take note of these adjustments and ensure alignment with the updated information.
6. All other provisions of the aforementioned Memorandum remain in effect.
7. Immediate dissemination of this Memorandum is desired.
