

Dairo who participated in the Division Meet had not taken part in the preceding Unit Meet. The player was allowed to join the Division Meet due to the coach's misunderstanding of the rules and procedures regarding player replacement and eligibility.

Upon review by the Division Screening and Accreditation Committee, the situation was thoroughly clarified. The committee provided clear explanations and interpretations of the established rules and procedures governing player participation. Through this guidance, the coach acknowledged her oversight and fully understood the lapse that occurred.


In adherence to the regulations and with respect to the integrity of the competition, the coach and players accepted the sanction imposed by the Division Screening and Accreditation Committee. As ruled, all wins earned by the team during the Division Meet were forfeited.
