

This pertains to the JuanSIM ng Bayan Program Bayanihan SIM Project, a project spearheaded by DICT in collaboration with DepEd, DSWD, DILG, BFP, PNP, DOH and LGUs. The project aims to provide free internet access to selected beneficiaries located within the mobile network service coverage areas of both underserved and unserved communities in key developmental locations nationwide. This will be operationalized through the procurement and distribution of SIM cards with subsidized data under the Free Public Internet Access Program.

Aside from the identification of recipient schools, learners and teachers, DepEd is expected to: (i) coordinate with DICT and other partner agencies on the preparation of distribution sites including schedules and orientation, (ii) facilitate the organized dissemination of SIM cards and related project materials in the identified school; (iii) provide necessary support for DepEd personnel or representatives involved in the distribution, subject to DepEd's internal policies and availability of funds; and (iv) identify Regional Focal Persons who will coordinate with the Regional DICT Office on this Project.

On December 8, 2025, the Bayanihan SIM Project Management informed DepEd that DICT have successfully procured the Bayanihan SIM cards, and deliveries are already underway to the DICT Regional Offices, with distribution anticipated to begin after a Grand Program Launch early next year (2026).
