4. To ensure the excellent performance of the team and its full participation, the practice is on February 28, 2026 and March 7, 14, 2026 and participation on March 15-22, 2026.

4. The first activity of the league is on March 1, 2026 8:00AM at City of Passi Arena, other game schedules and activities will be communicated at a later date.

5. The players are expected to maintain discipline on and off the court. Respect for management, coaches, teammates, officials, and opponents is required at all times.
