1. In line with the Department of Education's commitment to uphold and promote learner rights, protection, and well-being, this office, through the Education Support Services Division in collaboration with the Schools Division of Capiz, will conduct the **2026 Learner Rights and Protection (LRP) on Wheels, Regional Orientation of DepEd Order No. 06, s. 2026 and Launching of the We Are Child Advocates for Resilience and Empathy (We CARE) Program** on **June 3, 2026** at **Maayon National High School, Maayon, Capiz**.
2. The activity aims to achieve the following objectives:
  - a. Increase learners' awareness of their rights and various forms of abuse, including bullying, OSAEC, and CSAEM;
  - b. Promote appropriate reporting and help-seeking responses through age-appropriate child protection activities;

  - d. Strengthen awareness and understanding on child protection and safeguarding mechanisms in schools; and
  - e. Launch the We CARE Program of Region VI which promotes resilience, empathy, and child protection advocacy in schools.
3. The Regional Orientation on DepEd Order No. 6, s. 2026 shall be broadcasted live via DepEd Region VI Facebook page and shall be participated online by all teachers and school heads. Schools shall convene teachers in a venue with stable internet connection within their respective schools for the viewing of the online orientation. Photos of the school participation shall be submitted by the schools to their respective Division LRP Focal Persons for consolidation and attachment to the Division Accomplishment Report to be submitted to the Regional Office.
