**BASIC FOOD SAFETY TRAINING FOR CENTRAL KITCHEN AND SCHOOL KITCHEN

1. In adherence to **DepEd Order no. 13 s.2026**, titled **Institutional Guidelines on the Implementation of the School-Based Feeding Program**, this Office, through the School Health and Nutrition Unit (SHNU) of the School Governance and Operations Division (SGOD), will conduct a Basic Food Safety Training for Central Kitchen Implementers on **August 8, 2026 at 8:30 AM**. Venue to be announce.
2. This activity aims to:
 - a. equip Central Kitchen implementers with essential knowledge and skills on basic food safety principles and practices,
 - b. eliminate or minimize the spread of pathogens that cause food poisoning and other food-related diseases; and
 - c. promote the consistent implementation of food safety measures in Central Kitchen operations to safeguard the health and well-being of learner-beneficiaries.
3. The list of participants and technical working group is found in Enclosure no. 1 of this Memorandum.
4. The participants of this activity are entitled to service credits in accordance with DepEd Order No. 13 s.2024 titled *Revised Guidelines on the Grant of Vacation Service Credits for Teachers*. On the other hand, non-teaching personnel including the management staff shall be provided with Compensatory Time Off (CTO) as per Civil Service Commission (CSC) and Department of Budget (DBM) Joint Circular No. 2 s.2024, on *Non-Monetary Remuneration for Overtime Service Rendered*.
5. Expenses relative to the conduct of this activity shall be charged against SBFP funds and travelling expenses of participants are chargeable against local funds, subject to usual accounting and auditing rules and regulation.
