WHEREAS, the 2026 Palarong Pambansa officially the 66th Palarong Pambansa, was held on May 24-31, 2026 in Agusan del Sur, and served as the country's premier national multi-sport event organized by the Department of Education (DepEd) for student-athletes representing the eighteen (18) regions of the Philippines, the National Academy of Sports, and the Philippine Schools Overseas;

WHEREAS, Marthonne Andrie B. Dumolong, a Grade 6 pupil of Maayon Elementary School, in the Municipality of Maayon, Capiz, represented Western Visayas in the Elementary Boys' Athletics events at the said Palarong Pambansa and emerged as a double Gold Medalist by winning both the 100-Meter Dash and the 200-Meter Dash;

WHEREAS, Dumolong further distinguished himself by Anchoring the Western Visayas Team, together with Jake B. Pablo of Iloilo, Zachary M. Pallares of Antique, and Zian Gabriel Galaura of Roxas City, Capiz, to a Gold Medal and a new Palarong Pambansa record in the Elementary Boys' 4x100-Meter Relay, clocking 47.31 seconds and breaking the previous record of 47.81 seconds set in 2025;

WHEREAS, Gemwel M. Edaño, a student-athlete of Luis Escutin National High School and a native of Brgy. Duyoc, Dao, Capiz, represented Western Visayas in the Paragames – Visual Impairment (T11) category at the said Palarong Pambansa and won the Gold Medal in the Shot Put event, demonstrating exceptional strength, determination, and skill;

WHEREAS, Edaño further brought honor to the Province of Capiz by winning the Bronze Medal in the 100-Meter Run under the same Paragames-Visual Impairment category, further showcasing his versatility and competitive spirit as a para-athlete;

WHEREAS, Zian Gabriel Galaura, on the other hand, is from Roxas City, Capiz and a pupil of Filamer Christian University–Elementary Department. He participated in the Elementary Boys' 4x100-Meter Relay, together with Marthonne Andrie B. Dumolong and two other athletes from outside of Capiz, and successfully hurdle the Gold Medal award;

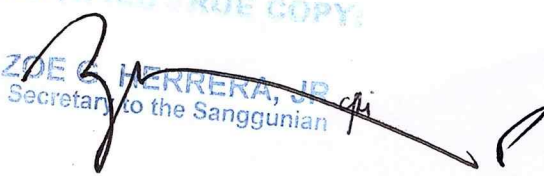

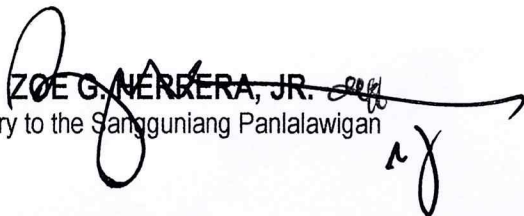

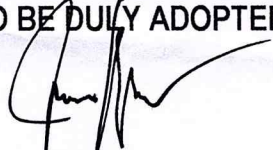
