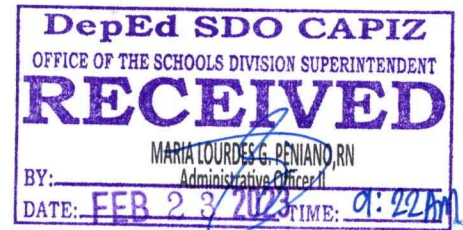

In line with our sustained campaign on substance abuse, may I ask an official endorsement from your Office to hold a series of preventive drug education [PDE] activities in various public schools, with strong thrusts on illegal drugs abuse, bullying, protection of children's rights, and family restoration. In presenting its PDE curriculum platform on illegal drugs, Buklod Pamilya Inc. [BPI, Buklod for short] has always embedded values formation [Good Manners & Right Conduct, GMRC] on its programs and projects.

Under the 2022 Comprehensive Dangerous Drugs Act [RA 9165], schools [public and private] are mandated to hold preventive drug education activities pursuant to, among others, Sections 43 [school curricula], 42 [student councils and campus organizations], 44 [par. 4, failure to report drug users and pushers], and 32 [liability of a person violating any regulation issued by the Dangerous Drugs Board [DDB] of the Philippines.

Since 2006 here in Capiz province, Buklod's strategic and tactical program/projects, or activities were complement to the national government's efforts on drug abuse demand-and-supply reduction campaign strategies, and are also calibrated to mainstream DepEd's mission-vision for a drug-cleared school, and workplace. *They do not disrupt classes.*
